The decision to invest in an ERP was a very strategic move by the management aimed to comprehensively manage and integrate Finance with Procurement, Projects, Inventory, Human Resources, Sales & Marketing, Audit and Information Technology. It was excellent team work properly planned, supervised, coordinated and executed that resulted in successful implementation of the ERP system. There were numerous interactive training sessions and simulations for the entire AHG staff who put in dedicated efforts to meet all time deadlines despite their day-to-day routine and job responsibilities. Initially we faced a bit of reservations and concerns from some quarters but through proper counselling and training the company managed to achieve the desired results at AHG Head Office and Diamondlease with Oracle EBS. The ultimate objective would be to integrate ERP across all the Al Habtoor Group subsidiaries to benefit from Centralized operations and Control.

Today, the Al Habtoor Group is well poised to meet all the challenges of Reporting and Statutory submissions, including Value Added Tax introduced by Regulatory Bodies which will come into force from January 2018. The ERP system will also be playing a crucial and pivotal role in the consolidation of financial reporting and other any future business plans. AHG management appreciates and recognises the efforts put in by all the staff members in their individual roles as well the good team spirit demostrated by all departments.





What does it mean for you?

Here are some of the most commonly asked questions...



What is VAT?

VAT is a tax on the consumption of goods and services levied at the point of sale and has been set at 5 per cent across GCC countries. This rate is among the lowest in the world, with some countries charging VAT of more than 20 per cent.

Where can I read more about it?

The official title is Federal Decree-Law No. (8) of 2017, on Value Added Tax. An English version is available on the UAE Federal Tax authority website (https://www.tax.gov.ae).

VAT puts a standard rate of tax (5%) on goods and services – why is it complex?

Several reasons:

Not everything will be taxed.
There are new legal concepts (and a bit of jargon) to understand.
Some things – like the place of supply of electronic services – can be quite difficult to define.
The GCC is a customs union – so,

4) The GCC is a customs union – so, implementing national VAT laws and

keeping the benefits of a transnational economic bloc may be a challenge. 5) Some GCC states (like the UAE) are further ahead than others, so all GCC states may not implement VAT on January 1, 2018.

Why isn't everything taxed?

 Some goods and services (for example education and healthcare) provide social benefits, so the government doesn't want to make them more costly than necessary.
A few things like "bare" land cannot be consumed (and VAT is a tax on consumption).

3) Some things (for example some financial services) are too difficult to tax.

4) Various goods and services are not taxed because they are exempt; others are not (in effect) taxed because the tax is 0% (zero-rated supplies). All such supplies are VAT-free to the consumer, but whether the supply is exempt or zero-rated will make a big difference to the taxable entity making the supply.



5) Water and electricity will be treated as supplied goods, and therefore subject to a 5 per cent value-added tax (VAT).

Are prices VAT-inclusive or not?

"Advertised" prices must include VAT. That means shop prices will be VAT-inclusive, providing clarity and certainty for the consumer – there won't be an extra 5% added to the sticker price at the cashier. Other instances, where the price might not include the tax (for example to wholesalers), will be explained in the Executive Regulation.

Will tourists be able to reclaim VAT?

The VAT Law says that the Executive Regulation may contain conditions for the return of tax paid by a non-resident for goods supplied in the UAE that will be exported. So, the answer is "quite possibly".

What should businesses be aware of now?

Businesses should be familiarising themselves with what the VAT Law says, and how it will apply to their business. Given that the start date for VAT is January 1, 2018, businesses should look, in particular, at the Transitional Rules (Article 80). **Source: The National**
